1. Who we are:

Little Hideaways, a holiday cottage letting service, where we book and sell stay in a select number of holiday cottages. We may add to our holiday cottage portfolio and any cottages that are included in our lettings service are covered under this privacy policy provide the bookings were made with us. We can not be held responsible for how third-party websites such as those named above handle your personal information.

Throughout the site, the terms 'we', 'us', and 'our' refer to Little Hideaways, registered at Grange Farm Cottage, Minskip, Boroughbridge, YO51 9HZ. Further contract details are available on our website under 'contact us'.

We are a 'data controller' for the purpose of the General Data Protection Regulation (GDPR) where we control the process for which we process your personal information. We will take all reasonable and appropriate steps to ensure compliance with the GDPR and all other applicable legislation relating to data protection. [we are not VAT registered.]

2. How do we collect information from you?

We obtain person information for our sole use at Little Hideaways and this is not passed onto third parties.

The information we collect includes but may not be inclusive to, name, address, email address, contact number, where you may be travelling from, if you own any pets that may accompany you on your trip and if you will be bringing a car on your trip.

3. What information we collect and how we use it?

We collect your information in order for us to fulfil our service and business obligations of providing your holiday rental. This involves using your information to contact you to confirm and arrange your booking details, send further check in information, send invoices and send further business information that may at times include marketing material.

4.1 Sensitive Data

We do not gather sensitive personal data such as health, genetic, biometric data, racial or ethnic origin, political opinions, religious or philosophical beliefs, trade union memberships, sexual orientation, and criminal convictions. We request that you do not send us such sensitive data.

4.2 Children's Data.

We do not collect information and data on children under the age of 16 and our services are not sold to children. Website visitor behaviours which is anonymised in order to analyse popular content, and better analyse where our customers come from and what they prefer. It helps analyse our website performance so we can continue to improve our services.

5.6 Email Marketing

We collect your contact details (for those that opt in to our marketing information). We do this in order to update customers on news about offers that might be of interest to them. We do this by using mail chimp as a third party newsletter provider. Customers can unsubscribe from our mailing list at any time.

6. Cookies

Like many websites, our website uses cookies. Cookies are small pieces of information that are stored on your computer or electronic device when you visit a website.

Cookies are used for:

6.1 Google Analytics – to accurately estimate the number of visitors to our website and the content that is most popular, including page views. We analyse this information to ensure we are providing the services to meet your needs.

6.2 Book a let – this is our booking system that captures your data and works with our third parties listed at the top of the privacy policy in order for us to provide you with a service, it allows us to send you conformations, invoices and check in information. It can be used to analyse our bookings, consider and analyse the proportion of new bookings to repeat bookings.

6.3 Third Parties – These are cookies set on your machine by external websites. Links to sites such as Facebook and Instagram. You should check the privacy policies of these sites to see how they store your information and be aware of how to opt in or opt out of their information before you access them. We are not responsible for third party policies or uses of personal data. By using the services of Little Hideaways, you consent to cookies being used in accordance with this policy.

If you do not consent, you must turn off cookies or refrain from using the site. Most browsers allow you to turn off cookies. To do this look at the 'help' menu on your browser.

7. Social Media
